- NOTE: Comes with show polished stainless tips.
- NOTE: Will fit 1998 models equipped with dual catalytic converters.
- NOTE: It is illegal, except for racing vehicles that may never be driven upon a highway, to remove the catalytic converter.
- NOTE: A muffler is supplied with this exhaust system. Hooker Headers has designed this kit in conjunction with the Hooker Super Competition Aero Chamber Muffler. Extensive track and flow testing has allowed Hooker Headers to produce the finest chambered muffler available.
- NOTE: The unique design of the Aero Chamber Muffler will create a throaty powerful sound that will not change with time. Proper installation and maintenance will ensure long life and maximum performance from your muffler.

BEFORE STARTING

Your vehicle must be raised a minimum of 36 inches. A floor hoist is ideal. If no hoist is available, we strongly urge the use of axle stands as a safety measure. <u>CAUTIONI</u> YOUR CAR SHOULD NOT BE SUPPORTED ON A BUMPER JACK. We recommend welding all pipe slip joints (headpipe to muffler, etc.). If no welding equipment is available at the time of the installation, use the furnished clamps to secure the pipes until they can be welded.

- NOTE: All Hooker Aero Chamber Mufflers feature aluminized and stainless steel construction for long life. The following tips are intended to help you realize the full potential of these mufflers.
- NOTE: Aero Chamber Mufflers are designed with a heavy gauge inlet and outlet stub for high strength. Standard muffler clamps will not properly crush the stub. Welding is recommended.

INSTALLATION PROCEDURE – PLEASE READ CAREFULLY

- NOTE: Use penetrating fluid on all nuts and bolts.
- 1. Unbolt and slide the wideband clamp back.

NOTE: Stock wideband clamp will be reused.

- 2. Cut the stock exhaust pipe at 34 inches and remove the headpipe.
- 3. Remove the nut on the right side exhaust hanger.
- 4. Remove the left side exhaust donut, tilt the muffler down, and remove.
- NOTE: You will need to remove the fixed stud on the right side hanger and use the supplied bolt and nut.
- 5. Install the headpipe along with the stock wideband clamp.
- 6. Install the right side hanger, headpipe extension, and clamp.
- 7. Install the muffler, left side tailpipe, hanger, and clamp.
- NOTE: Some trimming of the inlet end of the tailpipes may be necessary for various valance packages.
- 8. Install the chrome tips and right side tailpipe.

NOTE: Start at the headpipe when tightening and work to the rear of the car.

- 9. Start the engine and check for leaks. Be sure all brake lines, fuel lines, and any electrical wires have sufficient clearance.
- 10. When finished, give your car a test drive, checking carefully for any new noises. After several days of driving, retighten all bolts.
