

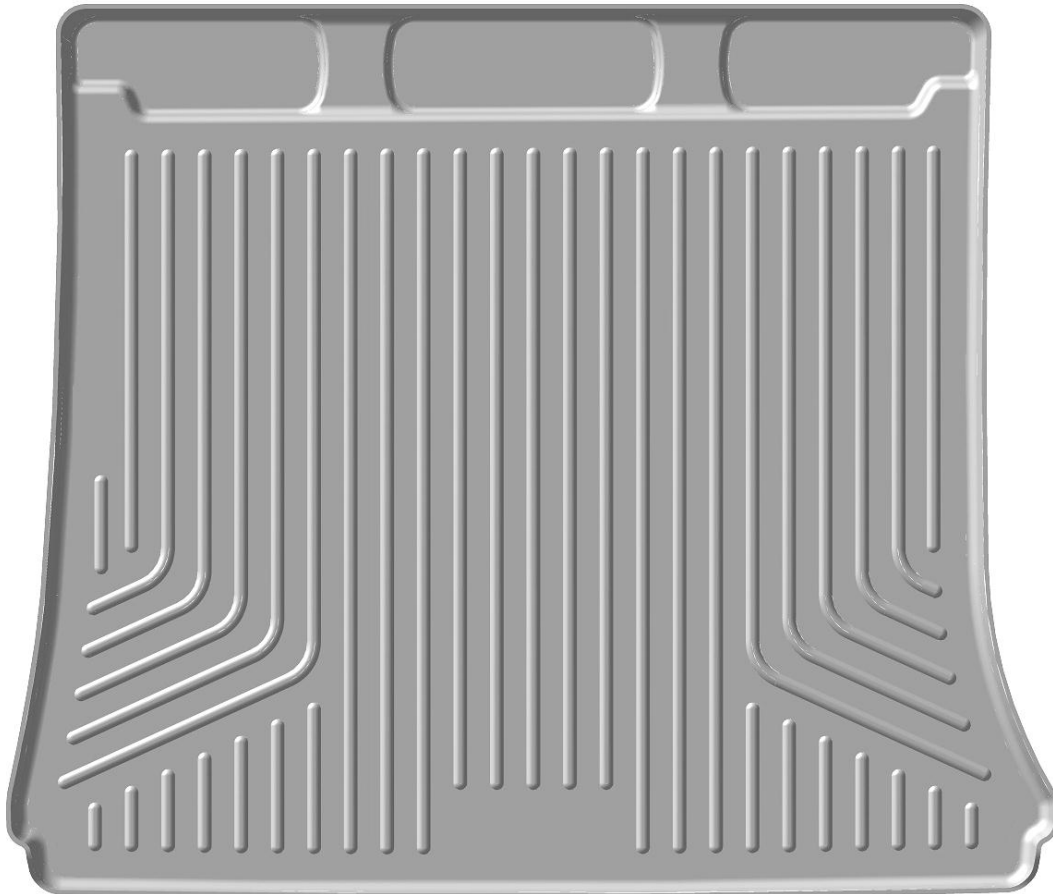
HUSKY **WeatherBEATER™** **Custom Vehicle Floor Protection**

CARE AND USE INSTRUCTIONS

Your new liner is custom molded to fit your vehicle. Upon removal from the box your liner will not completely unroll and lay flat. This is normal and only temporary. Just place the liner on the floor or in the back of your vehicle with a weight in each corner (a book works well). After a few minutes, your liner will remain flat. In colder climates this “relaxing” may take longer; moving the liner to a heated area will accelerate the process.

Your liner is manufactured using an engineering resin that is lightweight and extremely tough and durable. The easiest way to clean your liner is with a damp cloth or sponge. If using a cleaner, 409® or Glass Plus® work well. Use of Armor All®, Son-of-a-Gun® or similar items is discouraged as these products make the liner slick.

INSTALLATION INSTRUCTIONS FOR YOUR CHEVROLET EQUINOX/GMC TERRAIN CARGO LINER (VEHICLES WITHOUT CARGO CLOSE OUT PANEL*)



YOUR CARGO LINER IS DESIGNED TO WORK WITH THE SECOND ROW SEAT ADJUSTED TO ITS MOST REARWARD POSITION. YOU WILL HAVE TO SLIDE THE SECOND ROW SEAT TO THIS POSITION FOR THE CARGO LINER TO FIT PROPERLY.

*THE CARGO CLOSE-OUT PANEL IS A PLASTIC PANEL THAT COVERS THE GAP BETWEEN THE FRONT EDGE OF THE CARGO SPACE AND THE BACK OF THE 2ND ROW SEAT (SEE IMAGE ON BACK OF PAGE).

The foregoing is the only express warranty made by the manufacturer and is limited to the duration of this warranty. **ANY IMPLIED WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE IS LIMITED IN DURATION TO THE DURATION OF THIS WARRANTY. LABOR CHARGES, INJURIES, OR ANY OTHER LOSS OR DAMAGES WHATSOEVER, INCLUDING THOSE INCURRED IN INSTALLATION ARE EXCLUDED. ADDITIONALLY, PAINTING OF REPLACEMENT HUSKY LINER PARTS AND ANY VEHICLE COMPONENT REPAIR OR REPLACEMENT AS WELL AS INCIDENTAL DAMAGES ARE EXCLUDED.**

This warranty is void for damages to the product due to misuse, abuse, neglect, accident, improper installation or any use that violates the instructions furnished by us.

ABNORMAL WEAR AND TEAR ARE NOT COVERED UNDER THIS WARRANTY. Obviously, if your dog chews up your Husky Liner product, it's not covered under the warranty. Likewise, if you shut your Husky Liner in the door of your vehicle, damage to the liner and/or door are not covered. commonplace, everyday wear on a particular product is considered normal, and is not covered under warranty repair.
