



Installation Instructions:

- 1. Remove (4) 1/4-20 Hex bolts, lock washers, flat washers labeled (A)
- 2. Remove pivot plate labeled (B)
- 3. Set new pivot plate on flats of flippers labeled (C)
- 4. Install (4) new 1/4-20 Hex bolts, lock washers and flat washers labeled (A)
- 5. Center pivot plate left to right.
- 6. Align side surface of flippers labeled (C) to inside of housing labeled (D)
- 7. Tighten 1/4-20 Hex bolts labeled (A)
